The Aging and Disability Resource Center (ADRC) of Vilas County serves Vilas County and the Lac du Flambeau Band of Lake Superior Chippewa Indians. The ADRC provides benefits counseling for those between the ages of 17 years 6 months and 59 years with disabilities. A Disability Benefit Specialist (DBS) can help determine benefits and programs to which you may be entitled. A DBS will provide referrals, assistance and support on other matters including disability rights and the impact of earnings on financial eligibility for public benefits. A DBS can also help with: Medicaid, Social Security Disability Income (SSDI), Supplemental Security Income (SSI), Medicare, Prescription Drug Assistance, FoodShare, Low-income Tax Credits, Insurance Issues, Housing and Utility Issues, and Veteran's Benefits. Elder Benefit Specialists (EBSs) assist with similar complex issues for those customers over the age of 60.
