Centro Legal provides representation in **family law** matters, including child custody and placement, child support, divorce, property division, and restraining orders.

Centro Legal offers **flat-fee mediation** services to couples going through divorce. Their attorney-mediators have significant experience working with families to resolve legal issues, including custody, placement, child support, and the divorce process as a whole, and they have been trained to mediate divorces as neutral lawyers working with a couple jointly throughout their divorce.

Centro Legal represents individuals who do not qualify for public defender representation yet can't afford to hire a private attorney, in cases involving **misdemeanor criminal charges** including diversions and deferred prosecution agreements.
